# **Coalition for Physician Accountability**

### Update on Work of the UME-to-GME Review Committee

WASHINGTON, D.C. (November 12, 2020) The Undergraduate Medical Education to Graduate Medical Education Review Committee (UGRC), convened by the Coalition for Physician Accountability, is progressing with its work to examine challenges and recommend solutions to improve the UME-to-GME transition. The UGRC is set to hold its second virtual meeting on November 19-20, 2020.

### **Update from UGRC Co-Chairs**

"The UGRC met for the first time in mid-September and had productive and thoughtful discussions about the current state of the UME-to-GME transition. We reflected on our scope of work and reaffirmed our desire to make this review process as inclusive and transparent as possible. Our November meeting will be primarily focused on identifying an 'ideal state' of the UME-to-GME transition to help guide our work and identify common characteristics that all stakeholders want to see in a future transition. We will also explore the root causes of challenges that currently exist in the transition and how we can begin to address and eliminate such roadblocks.

As Co-Chairs of the UGRC, we are committed to frequently engaging with the medical education community, residents, medical students and organizations across the House of Medicine. In the coming weeks, we will be sending out further communications asking for valuable input from stakeholders that will help to guide our work and future recommendations. We hope to see and hear from many of you virtually throughout the duration of the UGRC's work and we look forward to working together to address such a critically important issue."

### **UGRC Guiding Principles**

The UGRC will be focusing on these important areas of consideration within the UME-to-GME transition:

- Optimizing fit between applicants and programs to ensure the highest quality health care for patients and communities
- Increasing trust between medical schools and residency programs

- Mitigating current reliance on licensure examinations given the limited availability of valid, standardized, trustworthy measures of students' competency and clinical care
- Increasing transparency for applicants to understand how residency selection operates
- Considering the needs of all types of applicants in making its recommendation
- Considering financial cost to applicants throughout the application process
- Minimizing individual and systemic bias throughout the UME-to-GME transition process.

# **Work Groups**

Four workgroups have been assigned to execute on the Review Committee's charge:

- A.) Ensuring Residency Readiness
- B.) Mechanics of the Application/Selection Process from the UME Perspective
- C.) Mechanics of the Application/Selection Process from the GME Perspective
- D.) Post-Match Optimization

Each workgroup has specific objectives as well as these important overarching themes:

- Diversity/Equity/Inclusion/Fairness
- Wellbeing-for all involved
- Specialty Specific Competencies
- Public Good
